1.	Membership in The Delta Kappa Gamma Society International shall be by
	invitation. A member inducted into the Society becomes a member of the
	international Society in addition to a state organization and/or a chapter.
2.	An individual becomes a member of the Society when she pays her dues.
Section	on B. Classification
1.

2.	Reserve membership shall be granted only to a member who is unable to
	participate fully in the activities of the chapter because of physical disability
	and/or geographic location.
	a. Reserve status shall be granted by a majority vote of the chapter.
	b. A reserve member, so requesting, shall be restored to active membership.
3.	An honorary member shall be a woman not eligible for active membership
	who has rendered notable service to education or to women, and is elected to
	honorary membership in recognition of such service.
4.	Collegiate members shall be undergraduate or graduate students who meet the
	following criteria:
	a. Undergraduate student collegiate members shall
	(1) be enrolled in an institution offering an education degree and have
	the intent to continue academically and professionally in the field of
	education; and
	(2) be enrolled within the last two years of their undergraduate
	education degree.
	b. Graduate student collegiate members shall have graduate standing in an
	institution offering an education degree and have the intent to continue

90	A member in good standing may transfer from one chapter to another upon
91	notification to Society Headquarters.

93	Section E. Termination of Membership
94	Membership in the Society is terminated for non-payment of dues and fees,
95	resignation, or death.

97	Section F. Reinstatement
98	A former member shall be reinstated to membership by the chapter receiving the
99	request.

101	Article IV
102	Finance
103	
104	Section A. Annual Dues
105	Each active, collegiate, and reserve member shall pay annual dues.
106	1. International dues shall be an amount recommended by the Executive Board
107	and approved by the international convention.
108	2. State organization dues shall be an amount determined in accordance with
109	state organization bylaws.
110	3. Chapter dues shall be an amount determined in accordance with the rules set
111	by the chapter.
112	
113	Section B. Fees
114	1. Induction Fee
115	An active member shall pay an induction fee at the time of induction.
116	2. Scholarship Fee
117	Each active and reserve member shall pay a scholarship fee annually.
118	3. Honorary Fee
119	The inducting unit of the Society shall pay a lifetime fee for each honorary
120	member at the time of induction.
121	
122	Section C. Payment of Dues and Fees
123	1. The membership year is July 1-June 30. A member shall pay annual dues and
124	fees no later than June 30 for the following fiscal year.
125	2. For membership or reinstatement commencing between July 1 and December

31, the member shall pay induction fee (new member only), dues, and

127	scholarship fee for the current year. For membership commencing on or after
128	January 1, the member shall pay one-half the international membership dues.
129	Chapter and state organization dues may be pro-rated as the chapter/state
130	organization determines.
131	3. Immediately thereafter, the state organization and international portions of the
132	dues shall be sent to the state organization treasurer.
133	4. The international portion of the dues shall be sent between July 1 and
134	September 30.
135	5. A member who fails to complete payment of international dues shall be
136	dropped as of October 1.
137	Proviso: This bylaw will take effect in 2019.
138	
139	Section D. Financial Assessments
140	Financial assessments may be levied only by the chapter.
141	
142	Section E. Other Income
143	The Society shall receive and utilize income from sources other than dues and fees
144	- including but not limited to gifts, bequests, and royalties - in accordance with
145	policies in the <i>International Standing Rules</i> or as determined by the Administrative
146	Board.
147	
148	Section F. Funds
149	The Delta Kappa Gamma Society International Funds
150	1. The Available Fund - <i>all levels</i>
151	At each level this fund shall be the operating fund and shall require a budget.
152	2. The Scholarship Fund - <i>all levels</i>
153	a. The Society and each state organization shall maintain a scholarship fund
154	for the benefit of members. A chapter may maintain a scholarship fund.
155	b. The scholarship fee paid by a member shall be divided as follows:
156	(1) one hundred percent (100%) to the state organization fund if the
157	chapter does not maintain a chapter scholarship fund or twenty
158	percent (20%) to the state organization fund if the chapter does
159	maintain a chapter scholarship fund.
160	(2) eighty percent (80%) retained by the chapter having a chapter
161	scholarship fund.
162	c. Rules governing international scholarships shall be recommended by the
163	Scholarship Committee and approved by the Executive Board. Rules
164	governing state organization scholarships shall be approved by the state
165	organization executive board.
166	3. The Permanent Fund - <i>international and state organization</i>
167	a. The Society and each state organization shall maintain a permanent fund.

- b. The Society shall set aside for its Permanent Fund twenty-five percent (25%) of its induction fees and annual dues until the total of the current assets in its Permanent Fund is not less than thirty percent (30%) of its Available Fund annual income, at which time further allocations shall be made as provided in the *International Standing Rules*.
- c. Each state organization with a headquarters facility shall follow the above (Section F. 3. b.) formula. When the percentage has been reached, the state organization executive board may reduce or discontinue further allocations.
- d. Each state organization which does not have a headquarters building should maintain an available fund reserve which is not less than one year's operating expenses.
 - (1) State organizations without a headquarters building are not required to maintain a permanent fund; but are required to maintain an available fund reserve. These state organizations without a headquarters building shall set aside up to twenty percent (20%) of their state organization dues until the total of the available fund reserve equals one year's operating expenses at which time the state organization executive board may reduce or discontinue further allocations.
 - (2) The available fund reserve may be used at the discretion of the state organization executive board.
- e. Investment income from the international Permanent Fund shall be allocated to the international Available Fund when received. Proceeds from the sale of international/state organization permanent fund assets shall be added to the principal of the international/state organization permanent fund. Investment income from the state organization permanent fund may be allocated to the state organization available fund by vote of the state organization executive board.
- f. The principal of the Society and state organization permanent funds shall be used for the following:
 - (1) purchasing induction paraphernalia;
 - (2) purchasing articles and equipment of a permanent nature;
 - (3) licenses for computer software;
 - (4) renting office space;
 - (5) constructing a headquarters building; and
 - (6) furnishing a headquarters building.
- g. International expenditures shall be reviewed by the Finance Committee and authorized by the Executive Board. Expenditures from the state organization fund shall be authorized by the state organization executive board.

211	4.	The Educators Award Fund - international only
212		This fund shall be maintained for the stimulation of educational research and
213		writing. Awards from this fund may be given annually by the Educators Book
214		Award Committee according to guidelines adopted by the Executive Board.
215	5.	The Emergency Fund - international only
216		This fund shall be for assistance to members who sustain major losses from
217		floods, tornadoes, hurricanes, and other natural, catastrophic disasters. The
218		fund shall be maintained by voluntary contributions. Awards shall be made
219		as directed in the <i>International Standing Rules</i> and Administrative Board
220		policies.
221	6.	The Eunah Temple Holden Leadership Fund - international only
222		The bequest of ninety-six thousand nine hundred fifty-nine dollars (U.S.
223		\$96,959) of Mrs. Eunah Temple Holden to The Delta Kappa Gamma Society
224		International was established in 1978 as the Eunah Temple Holden Leadership
225		Fund.
226	7.	The Golden Gift Fund - international only
227		The Golden Gift Fund commemorates the fiftieth anniversary of the Society
228		celebrated in 1979.
229	8.	The International Speakers Fund - international only
230		The International Speakers Fund commemorates the first international
231		expansion of The Delta Kappa Gamma Society International in 1952. The
232		fund was established in 1982 to mark the Society's thirty (30) years as an
233		international organization.
234	9.	The Loretta Halek Memorial Fund - international only
235		The Loretta Halek Memorial Fund for program resources is a memorial
236		established in 1974 to Mrs. Loretta Halek, first program coordinator of The
237		Delta Kappa Gamma Society International.
238	10.	The World Fellowship Fund - international only
239		The World Fellowship Fund shall be used to grant fellowships to non-
240		member women educators who are not citizens or permanent residents of
241		the United States of America or Canada. Rules governing fellowships shall
242		be recommended by the World Fellowship Committee and approved by the
243		Executive Board.

245	Section	n G. Financial Accounting
246		Fiscal Year
247		The fiscal year of the Society shall be July 1 – June 30 inclusive.
248	2.	Budget
249		a. The Finance Committee shall prepare the Available Fund budget
250		biennially. The budget shall enumerate sources of dues and non-dues
251		revenue and shall include expenditure categories for Society Headquarters
252		operational expenses and Society administrative expenses.

253	b. The budget shall be reviewed by the Administrative Board and adopted by
254	the Executive Board.
255	3. Audit
256	a. The financial records of the Society shall be audited annually by an
257	external certified public accountant.
258	b. The audit report shall be reviewed and adopted by the Administrative
259	Board.
260	4. Reimbursement
261	Reimbursement shall be provided for specified international and state
262	organization personnel for participation in official Society activities.
263	Article V
264	Organization
265	9. 9
266	Section A. Levele of Organization
267	Section A. Levels of Organization The business of the Society shall be conducted by the arganization on three (2)
268	The business of the Society shall be conducted by the organization on three (3)
269 270	levels. The three (3) levels of organization shall be chapter, state organization, and international.
271 272	 The term <i>chapter</i> shall designate the local unit. The terms <i>state</i> and <i>state organization</i> shall designate states, territories,
273	provinces, and countries where The Delta Kappa Gamma Society
274	International is organized.
275	3. The terms <i>International</i> and <i>Society</i> shall designate the overall organization
276	with the total membership.
277	with the total membership.
278	Section B. Chapter Level
279	1. Chapters shall be organized in accordance with state organization bylaws.
280	Each chapter so organized shall have no fewer than twelve (12) members. The
281	Society shall grant the charter.
282	2. Charter members shall be those who become members of the chapter at the
283	time of installation of the chapter. Any member who transfers her membership
284	to the new chapter at the time of its installation becomes a charter member of
285	the new chapter.
286	3. Each chapter shall have chapter rules which are consistent with the
287	Constitution and its state organization bylaws.
288	4. Coordinating councils may be organized in areas in which several chapters
289	exist.
290	
291	Section C. State Organization Level
292	1. A state organization shall be organized by the Expansion Committee with the
293	approval of the Executive Board.
294	

2. Founders of the newly organized state organization shall be members who

296		have accepted the responsibilities inherent to the successful functioning of the
297		new state organization.
298	3.	The new state organization shall have no fewer than forty (40) members of
299		whom twelve (12) to sixteen (16) may be founders.
300	4.	The founders of state organizations shall be known as state organization
301		founders. The twelve (12) original members of The Delta Kappa Gamma
302		Society International shall be known as The Founders.
303	5.	The Society shall grant the charter.
304	6.	Each state organization shall consist of chapters within the state organization
305		and members holding membership within the state organization.
306	7.	Each state organization shall have bylaws which are consistent with the
307		Constitution for the governance of the state organization and its chapters.
308		
309	Sectio	n D. International Level
310	1.	The Delta Kappa Gamma Society International shall consist of all state
311		organizations.
312	2.	The international organization shall induct and sponsor units of the Society in
313		countries where no organization of the Society exists.
314	3.	The Administrative Board shall study recommended areas of expansion to
315		new countries before submitting a recommendation to the Executive Board for
316		approval.
317	4.	The Society may give financial assistance to existing state organizations as
318		needs are determined.
319	5.	In the event that a state organization has no members of record, the
320		Administrative Board has the authority to recommend to the Executive Board
321		that the state organization be dissolved. By a majority vote of the Executive
322		Board, the state organization will be dissolved.
323	6.	Components of the International Level
324		a. Regions
325		(1) The state organizations shall be formed into regions for the purposes
326		of rendering better service to the membership including the
327		following:
328		(a) presenting international conferences
329		(b) offering leadership development pre-conference training at the
330		site of the international conferences
331		(c) selecting representatives for international committees.
332		(2) The Executive Board defines the number of regions and the
333		constituent state organizations of each.
334		(3) Area Representative (Canada) represents members in three (3) state
335		organizations in the Northeast Region (New Brunswick, Ontario,
336		Quebec), and represents members in four (4) state organizations

337	in the Northwest Region (Alberta, British Columbia, Manitoba,
338	Saskatchewan).
339	(4) Area Representative (Latin America) represents members in ten
340	(10) state organizations in the Southwest Region (Baja California,
341	Costa Rica, El Salvador, Guatemala, Jalisco, Mexico City (name
342	designated in Mexico City Constitution), Nuevo Leon, Panama,
343	Puebla, San Luis Potosi), and represents members in one (1) state
344	organization in the Northeast Region (Puerto Rico).
345	(5) A state organization, with the approval of its members, may apply to
346	the Executive Board for assignment to another region.
347	b. Forums
348	The Delta Kappa Gamma Society International shall have forums as
349	designated in the International Standing Rules.
350	(1) The plan for each forum shall be determined by its participants.
351	(2) These forum units serve the interests of members. Each DKG
352	member belongs to a forum unit determined by her region or area.
353	(3) The international president shall provide for appropriate orientation
354	of forum leaders.
355	(4) The Administrative Board shall provide for the following:
356	(a) the update and approval of the Guidelines for Forum Planning
357	which shall include both Society guidelines and operational rules
358	determined by each forum.
359	(b) the resolution of conflicts involving breach of rules contained
360	in the Constitution, the International Standing Rules, and in the
361	Guidelines for Forum Planning.
362	(5) At international conferences and conventions a definite time for
363	separate forums shall be scheduled for Canadian, European, Latin
364	American, and United States of America members to meet for the
365	purposes of discussing problems and concerns related to their areas.
366	(6) Forums shall report as specified in the <i>International Standing Rules</i> .
367	Article VI
368	Officers

373	International officers, all of whom must be members of the Society, shall be
374	a president, a first vice president, a second vice president, one (1) regional
375	director from each region (all elected), and the corporate secretary (employed).

384		secretary and assign the duties of the office to the executive secretary, who

386	3.	Chapter Officers
387		Chapter officers, all of whom must be members of the Society, shall be a
388		president, a vice president, a secretary (all elected), a treasurer (selected
389		by the executive board), plus the option of a second vice president and/or a
390		corresponding secretary (both elected).

393	1.	International
394		International related personnel shall be two (2) elected members-at-large, two
395		(2) elected area representatives, all of whom must be members of the Society,
396		and an appointed parliamentarian. It is desired that the parliamentarian be a

398	2.	State Organization
399		State organization personnel, all of whom must be members of the Society,
400		shall be defined in the state organization bylaws or standing rules. It is desired
401	2	that the appointed parliamentarian be a member.

444	d. The state organization and chapter presidents shall	
445	(1) serve ex officio, with vote, on the respective levels in the particular of the p	rocess of

467		other duties as the president or the executive board shall assign to her.
468	3.	Regional Directors - international
469		The regional directors shall be members of the Administrative Board and of
470		the Executive Board. They shall serve as liaison officers between these board
471		and their respective regions. They shall communicate with state organizations
472		in their region, conduct international conferences, and encourage growth
473		within the region. They shall perform such other duties as the president or the
474		Executive Board shall assign to them.
475	4.	Members-at-Large - international
476		The members-at-large shall be members of the Administrative Board and of
477		the Executive Board. They shall provide liaison between these boards and
478		the members. Each member-at-large shall perform such other duties as the
479		president or Executive Board shall assign to her.
480	5.	Area Representatives - international
481		The area representatives shall be members of the Administrative Board and
482		of the Executive Board. They shall encourage and support the growth of state
483		organizations within their respective areas and serve as liaisons between these
484		areas and the Administrative Board. Each area representative shall fulfill
485		additional duties as stated in the Constitution and the International Standing
486		Rules and carry out any assignments delegated to her by the president.
487	6.	Corporate Secretary - international
488		The corporate secretary shall
489		a. serve as the registered agent of The Delta Kappa Gamma Society
490		International;
491		b. serve as a member ex officio, without vote, on the Administrative Board
492		and on the Executive Board; and
493		c. be the executive department administrator (Society Headquarters).
494	7.	Secretary - state organization and chapter
495		The secretary shall keep minutes of each meeting of the organization and
496		furnish the president with a copy of such minutes. She shall serve as secretary
497		to the Executive Board. She shall carry on such correspondence as may be
498		delegated to her by the president.

This policy is intended to supplement but not replace any applicable state 1617 1618 and federal laws governing conflicts of interest applicable to non-profit and charitable organizations. 1619 1620 The components of the policy are as follows: 1621 1622 Conflict of Interest, Direct or Indirect Interest, Family Members, Duty to Self 1623 Disclose, Duty to Disclose Conflicts of Others, Determining Whether Conflict of 1624 Interests Exists, Disciplinary Action, Record of Proceedings, Compensation Matters, Annual Affirmation, Periodic Reviews and Outside Experts. 1625 1626 **Article XIX** 1627 **Dissolution** 1628 1629 In the event of a dissolution of the Society, the net assets of the corporation shall be 1630 distributed as follows: 1631 1. International 1632 Upon final dissolution or liquidation of the corporation, and after discharge or 1633 satisfaction of all outstanding obligations and liabilities, the remaining assets 1634 of the corporation shall be conveyed, transferred, or assigned to a corporation 1635 or other organization qualified under the Internal Revenue Code to carry out 1636 the purposes and policies set forth in these Articles of Incorporation, and 1637

which corporation or other organization will be exempt from federal income

1639	taxation under the Internal Revenue Code of 1954 or any subsequent Internal
1640	Revenue law. The Executive Board shall determine specific procedures for
1641	liquidating remaining assets and shall supervise disbursement of funds.
1642	2. State organization
1643	Each state organization shall provide in its bylaws for its own possible
1644	dissolution in accordance with the incorporation statutes of the political entity
1645	by which the state organization was chartered.
1646	3. Each state organization shall provide in its bylaws for possible chapter
1647	dissolution which shall include the following:
1648	a. Before a chapter is dissolved, the approval of the state organization
1649	executive board must be obtained.
1650	b. Careful consideration shall be given to the manner in which those
1651	desiring to maintain membership transfer to other chapters. International
1652	procedures must be followed.
1653	c. Any remaining funds in the chapter account shall be sent to the state
1654	organization treasurer and deposited in the available fund.
1655	d. Chapter paraphernalia, Society publications, and chapter records shall be
1656	retained in the state organization archives and made available for use.
1657	e. The charter must be returned to the state organization to be forwarded to
1658	the Society Headquarters.
1659	f. The state organization executive board shall decide whether the Greek

1665 1666	All Eliability Act
1667	Section A.
1668	As a means of furthering the educational purposes of The Delta Kappa Gamma Society,
1669	consent is given to the establishment and operation of an educational corporation
1670	under the Texas Non-Profit Corporation Act, to be named, "The Delta Kappa Gamma
1671	Educational Foundation," for such purposes and to be formed and operated in such
1672	way that said Foundation will be exempt from federal income taxation under the
1673	Internal Revenue Code now or which shall hereafter be in effect; and the proper
1674	officers of The Delta Kappa Gamma Society are authorized to advise the Secretary of
1675	State of Texas that The Delta Kappa Gamma Society approves and consents to the use
1676	of such name by said Foundation.
1677	
1678	Section B.
1679	Such officers of The Delta Kappa Gamma Society as are or may be designated in the
1680	bylaws of said Foundation are authorized to act as officers and trustees of The Delta

1681	Kappa Gamma Educational Foundation, and the International Executive Board of the
1682	Society is authorized to elect trustees of said Foundation, according to the bylaws of
1683	said Foundation.

1685	Section C.
1686	Consent is given to the use by The Delta Kappa Gamma Educational Foundation of
1687	the office of The Delta Kappa Gamma Society in Austin, Texas, as its office.
1688	
1689	Section D.
1690	This enabling act shall not be subject to revision or amendment. The act shall
1691	become void only upon the dissolution or liquidation of The Delta Kappa
1692	Gamma Educational Foundation as provided for in Article VII of the Articles of
1693	Incorporation of said Foundation.
